

TERMS AND CONDITIONS OF PROMOTIONAL EVENT „WARRANTY OF A GOOD TASTE”

I. Those Terms & Conditions describe the rules under which the promotional event “Warranty of a good taste” is being run and performed.

II. Administrator of the promotional event is Petvita Corporation Sp. z o.o. based on ul. Nowogrodzka 50/515 00-695 Warszawa, registered in the Register of Companies of National Court Registry under the KRS No: 0000581123, VAT No: 7010513199, REGON No: 362753443.

III. TERMS OF PARTICIPATION IN PROMOTIONAL EVENT „WARRANTY OF A GOOD TASTE”

3.1 The participant of the promotional event may only be an individual person who buys Petvita promotional products as a customer (hereinafter referred to as Customer).

The participant, in the day of buying the promotional products has to be an adult and has to have the full legal capacity.

3.2 The promotional offer lasts until the exhaustion of the budget allocated to the promotional event.

3.2.1 In case of exhaustion of promotional budget, Administrator will inform about the end of the promotional event via Facebook.

3.3 The participant is allowed to participate in the promotional event only once. During the whole duration of the promotional event, administrator will accept only one application from a single household.

3.3.1 In case of receiving more than one application from the same household, administrator will accept only the first application.

3.3.2 By “application from the same household” it is understood applications where the same address details are used, City, street name, house number. Moreover, one participant may participate in the promotional event only once.

This means that a participant can not apply using more than one address details.

3.4 Promotional event provides the opportunity to return a single Petvita product purchased during the time of promotional event.

3.5 Filling a claim form for the return of purchased Petvita promotional product is equivalent to applying to the promotional event.

IV. TERMS OF RETURNING A PETVITA PRODUCT

4.1 Allowed is to return product where the loss of the product does not exceed 20% of the weight in case of 2,5kg bags (500g), and 10% in case of 14kg bags (1,4kg).

4.2 Participant is obligated to return Petvita product in it's original packaging

4.2.1 Application where the Petvita product is returned in a packing other than original will not be accepted.

4.3 Participant can return Petvita product personally in the shop of administrator or by sending it to an address provided in article II of this Terms and Conditions.

4.4 Participant is obligated to secure the Petvita product sufficiently to protect it from damage in transport and delivery.

4.5 Administrator preserves the right to not accept the application which do not comply terms stated in articles 4.1-4.4 of this Terms and Conditions.

V. FINAL STATEMENTS

1.1 Terms and Conditions are subjected to the applicable laws.

1.2 All personal data provided by participants are used by an Administrator only for purposes of conducting this promotional event.

1.3 Meeting all this Terms and Conditions guarantee participation in the promotional event.
